I understand that reclaimed water is the highly treated, filtered, and disinfected effluent from the City's reuse treatment facility that may be safely used for irrigation of residential lawns, medians, common areas, etc. I understand that, due to the chemical composition of certain susceptible vegetation and I agree that I will not hold the City or any of its officers, employees, agents or contractors liable for damages which may occur due to interruption of service, nor for variations in service including pressure and volume, as stated in the City's Policies and Regulations or due to uses of reclaimed water for purposes not included in the application, and agree to defend and hold harmless the City from all claims and judgments arising therefrom the City by any person.

I, the property owner, agree to allow the contractor to act as my agent to apply for a building permit on my behalf. It is understood and agreed that the City shall have the right to enter the above premises at any time to connect or inspect the reclaimed water piping and fittings, to discontinue City utilities for nonpayment of service charges, for tampering with the service, for cross-connections with another service or water source or for any other reason that may be detrimental to the City System. It is understood that the customer agrees to become a reuse customer and will responsible for any costs incurred for services rendered if work is canceled by customer prior to completion. It is also understood that cross-connection of any kind is prohibited and upon discovery of a prohibited cross-connection, the potable public water system will discontinue service until the contaminant source is eliminated.
